- Entrants must be actively employed as either an NHS worker, care worker or key worker at the time of entry and at the awarding of any prize which they may win but otherwise, no other purchase is necessary. Once this information is satisfactorily verified, kitchen design house will confirm the winners. There will be one winner: the winner will be either NHS worker, care worker, and or key worker (key worker includes: education and childcare, health and social care, key public services, local and national government, transport workers, those in utilities, communication and financial services - you can view the official list of key workers online here).
